- 3. THE PARTIES AGREE TO DO EVERYTHING NECESSARY TO ENSURE THAT THE TERM OF THE AGREEMENT IS MET AND TAKEN INTO EFFECT PROPERLY.

CANCELLATION

4. PLEASE UNDERSTAND THAT BOOKINGS WITH POSH EVENTZ LLC ARE NOT SOLIDIFIED UNTIL A CONTRACT IS SIGNED AND A FIFTY PERCENT (50%) DEPOSIT IS PAID. FIFTY PERCENT (50%) OF THE DEPOSIT IS NON-REFUNDABLE. ALL BALANCES MUST BE PAID IN FULL (14) DAYS PRIOR TO YOUR EVENT. NO EXCEPTIONS; AS A RESULT OF NON-PAYMENT YOUR BOOKING WILL BE CANCELLED AND VOIDED. THANK YOU FOR YOUR UNDERSTANDING.
